



2025-2026 Player Contract

Congratulations on being selected to play with the Boston Imperials this upcoming season. We are excited to have you involved in our program. Please address any questions or concerns to administration prior to accepting this offer and the Contract Acceptance. The acceptance of this offer represents an important decision for both player, parents and our organization, and will form the foundation of a successful and rewarding hockey experience with the Imperials. Fee: Fees are published on the Boston Imperials website and enumerated during this check-out process. As part of your tuition you will receive:

- Full and split season teams -3 hours of ice time (2 Team Practices and 1 Skills) weekly. Additional practices with other teams available on request.
- Split season teams will attend 1 tournament With a total of 15-20 guaranteed games (including tournaments. Note: Tournament games are included in game total)
- Full-season teams include Full game schedule 35-40 Full Season games with 2 tournaments Note: tournament games will count towards the 35-40 game count).
- Preseason training/practices to take place the week before Labor day
- New game jerseys, socks, shells, practice jersey (Purchased separately)

Terms and Conditions

AS A FULL TIME PLAYER WITH THE IMPERIALS, I UNDERSTAND THAT THE IMPERIALS WILL BE MY PRIORITY TEAM. ALTERNATES ARE TO DO THEIR BEST TO ATTEND GAMES THEY ARE ASKED TO PARTICIPATE IN.

My player is required to register with USA Hockey and sign a Code of Conduct Policy with the league, USA Hockey, and the Club. By signing this Player Agreement,

I assume full financial responsibility for the payment of my child's tuition and all other necessary costs and fees associated with our participation.

I also acknowledge that should the player or parent fall into arrears on these payments for any reason, time being of the essence, this shall be considered a material breach of this Agreement, and Bright Matter Sports & Entertainment shall be entitled to refuse to allow the player to continue to participate in the games/practices remaining, in addition to any other remedies Bright Matter Sports & Entertainment is entitled to hereunder or by Massachusetts law.

Any open balances at the end of the playing season will be sent to collections and/or small claims court unless a payment plan (with Prime+3% interest) with Bright Matter Sports & Entertainment I further understand that the tuition is based on full rosters. Therefore, if we withdraw, we will, nevertheless, be responsible to pay the full tuition and we will not be entitled to any refund of the previously paid tuition, in whole or in part, regardless of injury or circumstance, including league and division placement

I understand and agree that, as a parent of a team member, I am a representative of the Boston Imperials. At all times, I will strive to be a good representative of the organization by conducting myself as the parent of an athlete and by always exhibiting good sportsmanship, win or lose, at home or away rinks and at any public facility.

I agree that neither I nor my player will engage in conduct, bullying or language which is profane, obscene, vulgar, or deliberately offensive that is directed towards a player's teammates, coaches, officials, parents, spectators or opponents. I will respect my player's teammates, opponents, coaches and parents at all times.



We agree to abide by the USA Hockey Code of Conduct and the Boston Imperials Code of Conduct as answered in the previous question.

We understand this contract does not guarantee playing time. We understand the Boston Imperials cannot guarantee team placement in leagues and division. By acknowledging this agreement you understand there is no refunds regardless of league/division placement.

Release of Liability/Acknowledgment of Risk: In consideration of being allowed to participate as a student, player, instructor, coach, counselor, assistant, parent or volunteer in any Boston Imperials program, the undersigned acknowledges and agrees that: Participation in or observation of ice skating, ice hockey and dry land sporting activities have inherent physical risks that may result in serious injury, including permanent paralysis or death. I knowingly and freely assume all such risks, both known and unknown, and assume full responsibility for my child's participation. I understand and agree that none of the Boston Imperials, its owners, officers, managers, directors, administrators, employees, agents, and coaches, or any referees, any ice rink or any employees of any ice rink used by the Boston Imperials shall be responsible or held liable for any accidents, injury (including paralysis and/ or death), loss of equipment or any other costs, expenses, damages or losses in connection with my child's participation. The participant is responsible for all medical costs for any injuries arising from, or by reason of, my child's participation in Boston Imperials activities. We also recognize there is no refund for injuries and we are entitled to select insurance provided by Crossbar in the checkout process.

I hereby represent to the Boston Imperials that my child does not have any known medical condition that restricts or prohibits participation in ice hockey, ice-skating or any related activity, and does not have any known medical condition that puts my child at greater risk of injury or death resulting from any risks associated with participating in Boston Shamrock activities. In the event of injury or illness to my child, I give permission to the Boston Imperials or its designee, or rink manager to provide, or to arrange for the provision of, emergency first aid. The Boston Imperials reserves the right to terminate participation in Boston Imperials activities based upon inappropriate behavior by any player or such player's parent or parents at any time without refund. I and my child shall act in a mature and responsible manner. Any behavior by any person that the Boston Imperials determines endangers the safety of other persons or property, or jeopardizes the Boston Imperials ability to conduct business, will result in such person's immediate expulsion from participation in Boston Imperials activities. I and my child may also be expelled from participation in Boston Imperials activities for delinquency in payment, failure to abide by all Boston Imperials and ice rink rules and directives, or falsification of registration information.

Force Majeure. Neither Party shall be liable for losses, delays, failure, errors, interruption or loss of games or practices, or other related activities by reason of circumstances beyond its reasonable control, including, without limitation, Acts of Nature (including fire, flood, earthquake, storm, hurricane or other natural disaster); league or tournament cancellations, or rescheduling; cancellations or rescheduling by other clubs, or ice controlled by the landlord, or third-party with priority over the ice ahead of Bright Matter Sports & Entertainment. No Party shall have no right to terminate this Agreement in such circumstances.

I, AS PARENT AND GUARDIAN, UNDERSTAND MY CHILD UNDERSTANDS, AS A FULL TIME PLAYER WITH THE IMPERIALS, THAT THE IMPERIALS WILL BE MY PRIORITY TEAM. ALTERNATES ARE TO DO THEIR BEST TO ATTEND GAMES THEY ARE ASKED TO PARTICIPATE IN.

I, as the Parent/Guardian fully understand and agree to the above contract, fully understanding its terms, and that I have given up substantial rights by signing it freely and voluntarily without any inducement.
