RAYHA Board Meeting Summary - October 20, 2025

Motion Updates

It was confirmed that all coaching positions are filled, including assistant coaches for the C-Squirts. No further action is needed regarding coach approvals.

Gambling Business

- September numbers were lower than expected, with a deposit check of approximately \$4,500.
- Year-to-date revenue is progressing as expected.
- A bingo hall event was highly successful, with potential for monthly recurrence.
- Another location expressed interest in partnering, pending their gambling manager situation.
- There was discussion about advertising product bingos more effectively, potentially through team calendars and social media.
- A request was made to update the information on the RAYHA website.

Year to Date Financials

- Income included gambling checks and registration fees.
- Expenses included utilities, coach reimbursements, software, and player development.
- Net income was positive, although lower than the previous month due to a smaller gambling check.
- The organization continues to receive income from bank interest.
- Ice payouts for October will be reflected in the next report.
- There are some outstanding payments from October 15th.
- Domain renewals need to be reimbursed, and default credit cards need to be updated.

Unfinished Business

Booster Club Updates:

 An agreement was reached with the boys' boosters for a buyout allowing all youth players in RAYHA jerseys to attend boys' hockey games for free. RAYHA and the boosters will each pay approximately \$350.

- Benefits include a full-page ad in the program, logos on warm-up jerseys and the game day lineup roster, logo on the sponsor banner, sponsor recognition during home games, and logo on the livestream wallpaper.
- The registration page will be used to provide a list of eligible players.
- The Marauders boosters are also being approached with a similar request for the girls' teams.

• Tryouts:

- Feedback was solicited on the tryout process, including registration.
- The process was similar to last year, with three groups.
- o There was some confusion about group assignments after day two.
- A suggestion was made to split squirt-level tryouts into upper and lower groups after the first session for better evaluation.
- o The possibility of reducing the number of tryout days was discussed.
- A question was raised about players missing tryout days and the potential for players to be placed on lower teams.

Team Placements:

- Discussion on difficulties with crossbar not supporting shuffling around.
- o Individual pricing of mite teams made things tricky.
- Suggested doing offers for mites to simplify the process.

Warm-up Ice:

- Discussed reducing September ice time at Roseville.
- Suggested giving a bigger window to release teams.

New Business

Coaches' Bags:

- There was a discussion about providing coaches' bags to Roseville coaches.
- Clarity was sought on the inclusion of Marauders coaches in this initiative.
- The possibility of offering a stipend to Roseville coaches to purchase their own bags was suggested.
- A list of Roseville coaches will be compiled.

DNS Issues:

- All domains are now managed in GoDaddy.
- It was requested that the DNS information be put on the shared drive.

Jersey Design Fee:

- A motion was made to pay Jeremy Lundquist \$300 for jersey designs.
- The amount of time put in by the designer was discussed.

General Updates

D2 Update:

- Game schedules are still pending.
- Waivers are being reviewed.

o Game sheet codes were communicated.

• Capital Improvement:

- There is approximately \$4,000 remaining for 2025 and approximately \$23,000 through 2027.
- Suggestions were requested for capital improvement projects.
- Ideas included improving the rink board and locker room board situation, a mural on the outside of the building, and a space heater in the penalty box.
- The possibility of an electric heater was suggested.

Boys Hockey:

- All travel team coaches are set.
- There is one remaining waiver.
- Roster sizes are small due to injuries and other factors.

• Girls Hockey:

- 10U and 12U are up and running.
- There is a tournament issue with 12A.
- A manager's meeting is scheduled.
- 15U tryouts begin on November 1st.

Mites:

- Mites are up and running.
- All teams have coaches and managers.
- o Intro starts on November 1st.
- Mite skills sessions have started.
- Website updates are needed for level coordinator information.
- There was discussion about the skill level spread in Mite 1 and 2.

• Registration:

- First payments went through on October 15th.
- Follow-ups are needed for missing payment information.
