#### 1. Call to Order

- e. Ryan indicated check for Splash Cove was needed ASAP as well
- f. Ross indicated check needed for CCD for Pucks & Putts
- g. Brian worked with Pure Hockey to get first store live
  - i. New players, Beginners and a few travel players have reached out to Blayne for number assignments

## 5. 2024-25 Program Outline

- a. Coaches Registrations
  - i. 19 total applicants thus far
  - ii. 8/12 is deadline for coaches applications
  - iii. Communication needs to be pushed out over the next week with reminders for everyone to register on the website, SafeSport reminders, etc.
  - iv. Will be a heavy year for background checks as well
  - v. Locker Room monitors have to be identified on rosters this year
  - vi. No temporary CEP Cards allowed by USA Hockey this year

- b. Coaches Meeting
  - i. Would like to hold prior to taking the ice and at the Civic Center
    - 1. Thursday, August 8<sup>th</sup> at 6PM is tentative date for this
  - ii. Topics to Cover: Try-out Plans, LiveBarn Usage, HUDL, Parent Meeting, Locker Room Plan, Season Plan, Goalie Plans, Ice Utilization, AED Locations, etc.
  - iii. Coaches will not need to be approved to attend
- c. Try-out windows will be sent via email to parents as well
- d. Preseason Schedule
  - i. 3-on-3
    - 1. Feel teams would need to be made as players arrive for each session
    - 2. 6U/8U on Mondays and Wednesdays time TBD
      - a. Will fill last time slot on Mondays and Wednesdays, if needed, with stick and puck or clinics
    - 3. 10U/12U/14U on Tuesdays and Thursdays time TBD
    - 4. Motion by Blayne for Cost of 3-on-3 to be \$75 for 4 sheets of ice (twice per week for 2 weeks); 2<sup>nd</sup> by Jim; Passed unanimously
    - 5. Will be open to other local clubs.
    - 6. Coaches will be appointed to teams basis availability and registrations
  - ii. Weekend/Age-Specific Clinics
    - Need to be registered for a team to sign up or a prior member of DYHA in the past two years to participate
    - 2. Designed to get players ready for try-outs
      - a. Motion by Blayne charging individually, per clinic (4 total sessions, ending 8/31) @ \$20 per session
      - b. 2nd by Jim
      - c. Motion passes unanimously
  - iii. Pre-Season Ice on Sundays
    - 1. Will be doing goalie clinics, skating clinics and shooting clinics
    - CC may be able to offer stick n pucks on Sundays too which would be manned by the CC staff
      - a. First stick and puck is 8/11
- e. Regular Season
  - i. Schedule to begin 9/2 with 9/7 being normal schedule for 6U/8U/House and giving travel teams practices

#### 6. Ice Contract

- a. This year's contract was through 3/22/25 for DYHA.
- b. Plan to ask to amen contract to for end date the week after Blue Note Cup and then buy as needed after that point.

## 7. Hockey Cards

a. Process has begun and will be checking in for updates in the coming weeks.

## 8. DYHA Pucks & Putts

- a. Will have Jello shots put together to sell on the course.
- b. Plan to have 50/50 raffle prior to teams getting on the course

- d. Plan to offer 4 Mulligans for \$40 per team
- e. First Place Prize = DYHA Jerseys for each team member
- f. Second Place Prize = \$50 per player to the CCD Clubhouse
- g. Third Place Prize = \$25 per player to the CCD Clubhouse
- h. Looking at potentially awarding winners of holes a DYHA cup and perhaps a free Stick and Puck but still working out those details.
