- 2. Committee Reports
 - a. Marketing Committee
 - i. Take out at local restaurants was looked into but due to contact tracing and restaurants being shut down, it is hard to schedule at this point.
 - b. Finance Committee
 - i. Organization appears to be in good shape based on Balance and P&L sheets
 - ii. Fidelity bond to protect the organization was brought up. It would be a couple of hundred dollars for the premium just to enhance controls.
 - iii. When Hunt does reconciliations, can have someone double check
 - iv. Director and officer insurance was quoted at \$500 a month. Put to a vote. All in favor.
 - c. Governance Committee
 - i. Did not meet this month. Will meet next month probably to tweak the handbook.
 - d. Coaching and Development
 - i. Reviewed bylaw definitions
 - ii. Question regarding ACE having role in discipline
 - iii. Player safety coordinator to collect concussion reports and allow for return to play. Also to track any illnesses at this point
 - iv. ADM coordinator needs to be established
 - v. Spring tryouts: naming coaches and picking players at their best. Naming teams in springs may help to create tournament bound teams. Only name the A team and pick 6-8 players in the Spring. Another round of tryouts in the fall can fill the additional spots. Tryouts will be open to all kids in all leagues but will have to pay a try out fee. If paid to tryout in the Spring, no tryout fee will be collected in the Fall.

 - i. Everything has remained status quo in our current environment.
 - Skills started on Wednesdays.
 - iii. Need to hold off on 3v3 due to significant rise in Covid positivity rates.
