c. Ice Time Planning

- September ice : Rebecca is exploring September ice at RIT
- Clinics : Coach Brian Hubacher & Coach Dan Craun are evaluating clinics with a mid-July target
- Submit SUNY Geneseo application for ice time

d. Jersey Discussion (Rebecca provided update)

- **Chance Jerseys:** contact – Justin Contestable
 - Examples provided : Embroidered, sublimated, **sublimated reversible**
 - Pricing: \$120 per set of sublimated reversible (jersey + socks)
 - Overseas shipping – tariff consideration
- **ChamBro Jerseys:** contact – PlayIt Again Sports
 - used for Blues team jerseys during 2024-2025 season (2 separate jerseys)
 - U.S. based & convenient for local production
 - Reversible sample was previously not up to the Board’s standard (presented ‘24 pre-season)
- **Board decision:** Rebecca will request a flat mock-up design from **Chance** (takes 30 days)
 - Rebecca will inquire on **additional jersey add-on timelines** & process
 - Switching to Chance may affect sizing; post on website if change happens

- **Waiting for official jersey guidance** from WNY
 - The possibility that full organization name may need to appear on jersey; “Geneseo Livingston Blues”
 - no change needed for 2025 – 2026 season

- **Revised logo** idea shared by Coach Lee Blum for 18U team usage

Additional Topics Discussed (Not on Agenda)

- **Apparel:** Squad Locker remains official team store
 - Squad Locker is open year-round, no minimums, delivered directly to individual
 - Other apparel/platforms may be managed by individual teams for fundraising
 - Pure Hockey interest in being potential sponsor (Robert shared info)

- **Game Sheets App:** (Karen shared from Empire)
 - requires 2 iPads (Blues have 1), to be stored at SUNY Geneseo college locker
 - Home team runs scorekeeping via app
 - YouTube video available on how-to-use

- **Paramedics:** (Suggestion by Melissa) to have at home games
 - following Spring League incident

 - While at the IRA, contact student at college desk
 - They will contact Campus Safety who are trained responders.
