- -Vote on Skate for Free Public Event- Co/Hosted with Palmer Arena, Need to set Date with Teri-Cost? (last year \$0) - September 20th 3-5pm
- -Approve Palmer Arena Agreement (\$200/HR Ice) - Amendment to the proposed Agreement, verbiage on concession use, banner placement and specific agreement. A few other small adjustments. Sane will present the changes to the Palmer Board and will send out for the DYH Board to approve. Shane will then sign on the DYH agreement to the changes.
- -Vote on Aug school fliers cost (\$250 last year) - Shane motioned to assign a \$1000 advertising budget for the year, Rachael seconded and all approved.
- -Set 4 MH Session Dates (add to fliers/FB/etc) - Tabled until August

- -Vote on 3x5 or 3x6 Registration Banners (reusable, no dates) - See above
- Palmer Arena Board approved DYH to sell hanging banners. 50/50 profit split with the arena. Size and cost will be discussed at the August meeting.
