- A. Outside teams requesting to play in D8 for the 2024-25 season.

- B. School/ Discretionary Waiver Changes Discussion
 - i. MH has done away with the school waivers in most situations as of January 2024. District 8 Associations discussed the possibility of making a District 8 policy. After reviewing each associations separate policies, it is best to let each association keep their individual policies as there was too many differences.
 - ii. Conversation Topics
 - 1. Possibly create a D8 committee to create a district policy.
 - 2. Issues with the AVB policy is that leaving the door open for second year Bantams to leave makes their policy no longer discretionary per MH legal counsel.
 - 3. Suggested that all associations make sure their updated policies are on their websites.
 - 4. Recruiting skaters from other associations is an issue. The only way for associations to regulate their own teams is when there is integrity from all associations.
 - Do the associations need to put policies in place to prevent recruiting by coaches? No promising free hockey or guarantees to play on a specific team.
 - 5. Rak suggested that we leave the policy as it follows MH policy.

- C. Opportunities for younger refs
 - i. District 8 rules state that a ref must be 15 years old, however there is a private group out of Rosemount that will get the kids certified and give them the ability to learn to ref at Mite Scrimmages, or similar. If you are interested in learning more, reach out to Paul Moen.
