VII. New Business-

- RiverHawk Rumble
 - The tournament schedule and pool assignments have been redone and resubmitted as games cannot start at 6:00 a.m. as on the previous schedule. The updated schedule was submitted to D5 late last week.
 - As of Thursday, a vendor pin was secured who could rush production, the cost is within the approved budget, and the pins have been designed and ordered.
 - As of Thursday, the Executive Board discussed local vendor options (Lazarre, Rally Gear, and 7 Legends) for apparel who could have capacity. It was confirmed there is no conflict of interest in using 7 Legends for the Rumble, as STMAYHA is not paying for design, ordering, or receiving any trade or benefit. 7 Legends was contacted to see if they could take on apparel, which they can. This was set to be discussed at tonight's Board Meeting, consistent with the previous 7 Legends disclosure recorded in the minutes for the Kickoff Event.
