



**Lemont Lightning Travel Baseball & Softball**

**PARTICIPATION, WAIVER AND RELEASE AGREEMENT**

**PLEASE READ THIS CAREFULLY BEFORE SIGNING, THIS IS A RELEASE OF LIABILITY.**

**In consideration of my child being allowed to participate in any way in Lemont Lightning Travel Baseball/Softball League, related events and activities, I, being the parent/guardian of the participant of age agree to the following waiver and release:**

- 1.) I understand and acknowledge that my child or ward, will be engaging in hazardous activities that involve risk of serious injury, including permanent disability or death, and severe social and economic losses, and property damage which might result not only from my child's action, inactions, or negligence, but also from the actions, inactions, or negligence of others or the condition of the terrain, natural and manmade hazards and obstacles, facilities, or pre-existing conditions or equipment used by my child.
- 2.) I assume all of the foregoing risks and waive any claim that I might have against the Lemont Lightning Travel Baseball/Softball League and its managers, coaches and volunteers as a result of injury, permanent disability, death, social and economic losses, and property damage incurred in the activity, even if caused by their negligence.
- 3.) I have been given the opportunity to ask questions of appropriate Lemont Lightning Travel Baseball/Softball League personnel concerning such risks and hazards and acknowledge that any questions have been satisfactorily answered. I have received sufficient information and time to make an informed decision about my child's participation in the activity.
- 4.) I further agree to hold the Lemont Lightning Travel Baseball/Softball League and its managers, coaches and volunteers harmless for physical injury to or the death of others, or for property damage, which results from my child's participation in the activities of the Lemont Lightning Travel Baseball/Softball League.
- 5.) This waiver and the release of liability also applies to any rental or loan of equipment from the Lemont Lightning Travel Baseball/Softball League.
- 6.) This waiver and the release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

NOT CHANGED IT ORALLY, AND SIGN IT VOLUNTARILY.
