ARTICLES OF INCORPORATION

Sheridan Community Recreation, Inc.

The undersigned, being three or more natural persons of lawful age, at least a majority of whom are citizens of the United States, do hereby adopt the following Articles of Incorporation, representing beforehand to the Secretary of State of the State of Indiana and all persons whom it may concern, that a membership list or lists of the above named corporation for which certificate of incorporation is hereby applied for, have heretofore been opened in accordance with law and that at least three (3) persons have signed such membership list.

Be it further remembered that the following Articles of Incorporation and all matters heretofore done or hereafter to be done are in accordance with "An Act concerning domestic and foreign corporations not for profit, providing for fees, providing penalties for the violation thereof, and repealing certain laws," approved March 7, 1935, and all acts amendatory thereof and supplemental thereto.

1. The name of this corporation shall be Sheridan Community Becreation, Inc.

12. Any other provisions, consistent with the laws of this state, for the regulation and conduct of the affairs of this corporation, and creating, defining, limiting or regulating the powers of this corporation, of the directors or of the members or any class or classes of members:

To solicit, receive and accept by gift, devise or bequest all kinds of property including, but not limited to money, bonds, stocks, real estate and personal property or income therefrom, with full power of control and disposition of the same consistent with the purposes hereinabove set forth;

To administer such property or funds together with the income therefrom, with full tower of disposition and control thereof, unless limited by the terms and conditions applicable to specific gifts, devises or bequests made to and accepted by the corporation;

To do any further and additional acts and things as may be necessary, incidental or convenient to the attainment of the purposes herein expressed and in the administration of its funds and property to achieve those purposes; and,

To exercise any right or privilege allowed or authorized by law not herein expressed or implied not inconsistent with the purposes of the corporation.

The Board of Directors shall manage and administer the affairs of the corporation and shall do all things necessary and proper to carry out the purposes of the corporation, with power to appoint committees and to delegate such authority as it may deem expedient for carrying out the objects and purposes of the corporation.

The Board of Directors shall have the power to make, alter or repeal the bylaws of this corporation provided that the affirmative bote of not less than Seven (7) members of said Board shall be necessary to effect any alteration, amendments or repeal thereof.

This Corporation is not organized for pecuniary profit and shall not engage in any activities for the profit of its members. Officers and members of the Corporation may receive, however, remuneration for actual services performed at the instance and request of the board of Directors.
