NCYH Registration Agreement* (Agreed to when registering for the 25-26 Season)

Registration:

•All registration fees must be completed online. A non-refundable deposit as stated on the website is required to register for NCYH. A player is not considered registered until the deposit has been made. Travel fees will be automatically billed upon team placement. For your convenience, NCYH offers a convenient payment plan.

Important Registration Information:

•Returning NCYH players will have exclusive access to register during the first two weeks of registration (June 2–15). An email will be sent out to current NCYH members, and the announcement will also be posted on social media and the NCYH website. •New-to-NCYH players may begin registering after June 15, but per CAHA regulations, registrations will not be accepted or processed until after July 1 for non-returning members. •Please be aware: No roster spots are guaranteed for players new to NCYH. •If you are not accepted, a full refund will be issued. Refund Policy:

NCYH Financial Commitment Policy

•Once a player has been selected and placed on a team, the family is financially responsible for all dues and tuition for the upcoming season, regardless of future participation status. •No player release will be granted until all financial obligations have been paid in full, including but not limited to tuition, team fees, and any outstanding balances. •If a player is required to relocate out of the area or suffers a season-ending injury, tuition may be prorated based on the portion of the season completed, subject to review and approval by NCYH. •Participation in tryouts or evaluations constitutes a formal commitment to the NCYH program. By doing so, players and their families acknowledge and agree to abide by all associated policies. •Please note the Registration Fee and \$60 Capital Improvement Fund will not be refunded.

•Volunteering Commitment:

As a member of NCYH, a player's family is expected to score their family's share of their player's games. Members are also expected to volunteer during NCYH tournaments that their player's team participates in.

•Player Placement:

The Coaching Staff along with the NCYH Hockey Directors have sole responsibility of player placement on a team. No refunds will be given for players who choose to leave because he/she did not make the team they wanted.

•Code(s) of Conduct:

All players will be responsible to review and adhere to the Northern Colorado Youth Hockey

Player Code of Conduct. All players Squirt through Midget will be required to sign the Player Code of Conduct in acknowledgement of this policy.

•All parents will be responsible to review and adhere to the NCYH Parent Code of Conduct. At least one parent in each household will be required to sign the Parent Code of Conduct in acknowledgement of this policy.

•Code(s) of Conduct will be provided upon team formation.

•Privacy Information:

I understand that receiving a directory and personal information of other families on my team is a privilege with responsibility. With that understanding, I agree that I will be respectful of others by waiting 24 hours before putting any complaint/concern in writing and then will email/mail my written concerns/complaints ONLY to the appropriate designated NCYH individuals responsible for resolving issues. Please refer to the NCYH website for the Grievance Policy and NCYH Board member contact information. I further agree that I will not use the NCYH family contact information made available to me to solicit business or other opportunities without prior approval from the NCYH board.

•NCYH reserves the right to disclose player information to other youth hockey associations with respect to the player's financial standing.
