NCYH Financial Agreement* NCYH Financial Commitment Policy

- Once a player has been selected and placed on a team, the family is financially responsible for all dues and tuition for the upcoming season, regardless of future participation status. No player release will be granted until all financial obligations have been paid in full, including but not limited to tuition, team fees, and any outstanding balances.
- If a player is required to relocate out of the area or suffers a season-ending injury, tuition may be prorated based on the portion of the season completed, subject to review and approval by NCYH.
- Participation in tryouts or evaluations constitutes a formal commitment to the NCYH program. By doing so, players and their families acknowledge and agree to abide by all associated policies.
- Please note the Registration Fee and \$60 Capital Improvement Fund will not be refunded.
- All players are expected to participate in all tournaments selected by the Coach. Players not participating in a tournament are not entitled to any credit. This policy also applies to travel expenses associated with league games.
- If a player is on a payment plan and chooses to leave the association, that player is responsible for the remaining unpaid travel and team fees. NCYH Hockey will not issue a financial release until all outstanding fees have been paid.

Player Placement:

The Coaching Staff along with the NCYH Hockey Directors have sole responsibility of player placement on a team. No refunds will be given for players who choose to leave because he/she did not make the team they wanted.

"No Pay, No Play" Policy

The following policy applies to participation in hockey programming with Northern Colorado Youth Hockey ("NCYH"). NCYH has at times, and will continue to, provide financial flexibility to its members with its various payment options and assessment schedules, but will strictly adhere to the policies set forth below.

1. Players with outstanding NCYH registration fees from any prior season or NCYH hockey programs offered will not be allowed to tryout or play in any subsequent season or program until the outstanding NCYH registration fees are paid in full. There will be no exceptions to this rule.
2. All NCYH registration fee payments are due in the amounts and at the times set forth in the Registration Fee schedule listed on the NCYH website/Registration Form. a. Issues with registration fee payments should be brought to the attention of the NCYH Office

Administrator prior to the payment due date.

- 3. All NCYH team fee assessments are due within thirty (30) days from the date of assessment. a. Issues with team fee assessment payments should be brought to the attention of the team treasurer prior to the assessment due date.**
- 4. Payment issues brought to the attention of the NCYH Office Administrator and/or team treasurer will not trigger an automatic player suspension for non-payment, so long as satisfactory financial arrangements have been made with, and approved by, the NCYH Office Administrator and/or team treasurer.**
- 5. If a player's registration fee payment or team fee assessment payment is past due, and if other financial arrangements have not been approved by the NCYH Office Administrator and/or team treasurer, the "no pay, no play" policy will immediately take effect. The player's family will be notified by the NCYH Office Administrator, as appropriate. The player's family will be provided an opportunity to present payment or provide a good faith effort toward reconciling past due fees. Payment compliance must be made at that time, or the player will be immediately suspended from all NCYH activities.**
- 6. Players suspended for non-payment will not be allowed to return to the ice, including practice or game, until all outstanding financial obligations are met, as determined by the NCYH or NCYH Office Administrator.**
- 7. Suspension of a player for non-payment does not release the player or parent from the obligation to pay all registration fees or all additional team fee assessments.**
- 8. All NCYH financial obligations must be paid in full before NCYH will approve a financial release of a player.**
