 - o Administration-Jacki Patterson-
 - Discussed jersey pricing, with stitched jerseys costing \$160 each and sublimated jerseys being roughly half that price. The board reviewed voting results, where 34 families voted for stitched jerseys and 22 for sublimation, with 56 families participating in total.
 - o Competitive Teams- Dave Karraker
 - reported on his participation in Moam meetings and gaining access to a new message board, while noting he would forward formal documentation when available.
 - It was shared that Moam Board has made trainer attendance at games mandatory for U16 and above teams, with Moam covering 50% of the first-year costs.

- reported strong interest in coaching positions from the previous learn-to-play program, and mentioned he needs to follow up on scheduling meeting details with Jackie.
- House Programs- Angie Mizeur

o Financial Report/Register- Salam Kelleher

- Check Approvals
 - reimbursing two 17-year-old referees for \$110 each, which the board approves.
 - PO Box will automatically renew for \$192.
 - looking into purchasing wooden sticks for ADM, with the cheapest option costing around \$570 for 30 sticks.
 - The organization has secured D&O insurance and liability coverage for the deck rink through Bailey Family Insurance.
- Registration can be opened
 - Registration for the 16U team is open, but registration for other age groups is pending finalization of dues.
 - Tryout dates are close to being finalized and should be announced within 7–10 days.
