### Secretary's Report: Anne Phaneuf

#### President's Update: Jaclyn Hill

Discussed update on loss of a WYHA coach, Derek Krueger. Discussed steps for grief and resources for how to discuss with kids. Held a town hall on Sunday, November 2nd. Many coaches that will be most impacted attended, which was helpful. Board members have received positive feedback regarding the response.
