Greg motions to approve as written and Ben seconded. All in favor. Motion passed.

- b. Siouxland Sled Hockey
 - Aaron Wavra reached out to inquire about ice time.
 - Historically have had practice times on Sundays. We have donated the ice time. Requesting every other week this season.
 - Do we have the ice time available?
 - First have of the season, yes → after that it will be tight.
 - Give them 5 (1 ½ hour) dates for free. Re-evaluate after that.

Ben motions to approve 5 (1 ½ hour) ice spots for Siouxland Sled Hockey, contingent on availability (reevaluate for more later) and Greg seconded. All in favor.

- c. Coaching Reimbursement Policy
 - Parent coaches
 - Reimbursement for coaching certificate, classes, modules, CEP, and registrations associated with hockey.
 - Non Parent coaches
 - Same as parent coaches → also reimburse mileage and lodging
 - Lodging
 - i. New policy states they must stay at hotel with team or not eligible for reimbursement.
 - ii. Non-parents may want to stay elsewhere to save money, Coach Heitland states last season the high school coaches started staying in VRBOs as they found that they could all stay in one and it was cheaper than them each getting a room at a hotel.
 - C. Is this a budget concern or a supervision concern?
 - D. Parents take players and are responsible for them.

Ben motions to approve policy changing that coaches can stay in cheaper accommodations and Greg seconded. All in favor. Motion passed.

d. MN D4

- Brad spoke with Mike Pigman, D4 has voted that LAHA is welcome to schedule games with D4 teams that willing, but will not be in any leagues.
- Should have success scheduling with Windom, Luverne, Worthington, and Fairmont.
