3. Old Business

- a. Construction Updates

 - Light above door? Possible camera?
 - Locker room 2 and 3 door jam fixed.

 - Possibly move mini splits to the chiller room. Dulin would be willing to donate some labor.
 - Need heat option for JV locker room.
 - Chandler requests a white board for the Ref room.
 - Zam blades need to get to Mankato.
 - Crows nest stairs have been installed. Possible grab bar needed at the top?

 - Stairs by the zam room?
 - Communication to go out that gear must go home.
 - o Brad will also communicate with team managers
 - Include that LAHA is not liable for any damage to equipment left at the rink.
- e. Alcohol During Youth Events
 - Away team openly drinking in stands at HS game.
 - Send communication to incoming teams that we do not have alcohol in the building.
- f. Tournament Volunteering
 - Problems getting volunteer spots filled.
 - Should we support players loosing playing time if parents are not doing their part.
 - Other options
 - o Sign people up for spots, if they don't show up, chart them a fee
 - o Cut open skate opportunities to force volunteering in other areas.
- g. How to videos
 - Videos on how to do certain jobs that may seem overwhelming to volunteers.
 - o Scoreboard
 - o GameSheet
 - Open/Close drawers
 - Some of these may already exist.
