 - Ref fees, district fees are going up. Continue to be careful not to price people out
 - Decrease Bantam C by \$300

 - Increase mite from 8 to 10 hours (max at 20)
 - Increase travel from 12 to 15 hours (max at 30)
 - HYHA Board
 - 3 HQ shifts (15 hours) across hosted tournaments for all officers, directors, and non-voting members
 - Mite coordinators fulfil at Mite Jamboree
 - \$150 fee for non-completion
 - No regular dibs hours
