- 1. Called to order at 5:34 PM
  - a. Attendees: Karen Rickard, Chris Tippett, AJ Muldrow, Roger Bradley,
     Holly Balogh
- 2. Approve 2025 05 29 Meeting Minutes

## AJ moves to approve, Roger seconds, all in favor, Meeting Minutes approved.

- 3. CAHA meeting notes:
  - a. Voted the boys 12UAAA team down at the CAHA level
  - b. Waiting for CAHA BOD results to be ratified, then CAHA will make a statement that the 12U AAA Boys team isn't happening
- 4. Review hasty approval of 2025 05 14 Meeting Minutes
  - a. Remove **names** of scholarship recipients. Reword to imply that there are 11 applicants, and 4 made the team.
- 5. TCHC Bylaws edits for the scholarship committee (new Section 8.2.4)
  - a. Discussion regarding
    - i. eligibility
    - ii. "Is financial assistance required if you make the team?"

Holly motions to approve Section 8.2.4, AJ seconds, all in favor. Section 8.2.4 is approved.

- 6. Age division reps
  - a. How to handle the chain of command of communication?

Holly motions that the chain of command is "Parent  $\rightarrow$  Team manager  $\rightarrow$  Coach  $\rightarrow$  Secretary of the BOD." The Secretary can call the President and/or the Director or add the issue to the TCHC BOD meeting agenda. Karen seconds, all in favor. Motion passes.

- 8. Quickbooks

Karen moves to grant permission to Claire to be the primary owner of TCHC QuickBooks account, with the caveat that Team Colorado is a non-profit and Claire has no actual ownership of the club. Chris seconds, all in favor, motion passes.

- 9. Fundraising
  - a. EIN is 37-2168312
  - b. Discussion regarding restaurants' fundraiser nights, Karen supports
     it. Advertise these fundraisers on TikTok and Instagram with the players' content
- 10. The budget was for 60 players, but 2 teams are a few girls short. (14s has 11 forwards and 6 D)
  - a. We are at a \$24,000-28,000 budget deficit.
  - b. Moving forward, we will base the budget on a lower number of players
  - c. We don't want to water down the teams. Don't want to go back and ask for more money.
  - d. College camp has low attendance at this point. We'll break even/ Need to share with Dallas, Anaheim, Utah, WYO.
- 11. Did not book ice on July 6, but it's already booked. Instead, for TC families, Firecracker scrimmage. Big girls and little girls at different times. \$315/hour 2.5 hours. Need 40 people
