1. Fundraising Discussion

- a. Logo drive - The goal is to have all the logos by July 25
 - i. Most logos have been sent, and we now need to gather the checks.
 - ii. Some donors want to pay using QBO, and since we don't have access to the account (they need Randy to approve the change to account ownership), we don't know if we can issue an invoice through QBO. Can we still issue invoices and have the money go to the right account?
 - iii. Team logo update: 19U - 20, 16U - 9, 14U - 10
