### II. Officer Reports

- a. President (Trovato:) LTP started, great numbers: 22 skaters for session 1. Last year there
  were 8 skaters for the first session.
- b. Treasurer (Brown:) 138k in bank, 5k due, uniform invoices in for socks etc,
- c. Coaching Director (Tobin) Unable to attend, running a tennis clinic.

#### III. Open Business

- a. Apparel/Uniform Update (Thumith): Nothing new to report. Team store closed. Additional items ordered.
- b. Little Bruins Update (Smith) need to confirm DT and LHS participation (10/14, 10/21, 10/28, 11/4): We currently have 21 enrolled, a welcome email will be coming soon the families. Certificates and helmet stickers from Bruins LTP will be mailed out. Invoices are being prepared. Dracut and Lowell High coaches and players to cover the coaching aspects for the 4 sessions. As an organization, we need to try to retain more players than in years past. Information will be provided to Bruins LTP families on our Development team and Learn to Play options. Additionally, we will need to order 40 small/medium youth black LTP jerseys.
- c. 2023-24 Tournaments (Brendan Akashian): All teams have tournaments scheduled except for the Mites. Mites have a few local options to consider.
- d. Mite full ice supplemental update: Tryout process was described to all Mites. The families were notified about the cost and details. Initially, 13 players were thought to make up this team. With that said, only 12 players/families so far have reached out expressing interest. If that number stays the same, all will be added to that team and no try out will be necessary.

e. Additional tournament funding for Squirt-Bantam? We already have allocated \$1000 for squirts-bantams for tournaments. We are increasing that by \$500 for the teams.
