Academic Guidelines

Students attending PHA are considered homeschooled or distance learners. The academic requirements for these groups vary.

PHA is the host site to support each student in making appropriate academic progress- we do not determine the requirements.

We are pleased to help each student navigate their journey. PHA students are supported throughout the day by highly qualified teachers, experienced success coaches, and dedicated athletic development staff.

Admission

Families applying to Prospects Hockey Academy must demonstrate to the Administration a desire for a unique educational environment where complete student-athlete development is the focus. PHA will determine admission for students in grades 5-12 individually.

Arrival/Dismissal Procedures

Supervision in the PHA classroom will begin at 8:00am and conclude at 3:00pm.

Arrival is from 8:00-8:15 am. Students should be dropped off at the roundabout in front of the South Rink Main Entrance.

Dismissal is from 2:45- 3:00 pm. Students should be picked up at the roundabout in front of the South Rink Main Entrance.

Please use the attendance line to communicate all dismissal changes including releasing the student to anyone other than a parent/guardian. For student safety, please communicate changes as soon as possible.

Apparel

Students will be provided with a Prospects practice jersey and gloves. All students are required to have black, white, or navy blue hockey socks.

Additional apparel may be purchased through the PHA website.

Attendance

Absences, late arrivals, and early dismissals will be reported by 8:30am. Please leave a message on the classroom voicemail: 314-260-1457.

Behavior

Prospects Hockey Academy recognizes that each student has different needs. We value an individualized approach to meeting those needs.

Students will follow the expectations set forth by staff to ensure an equitable and positive learning environment for all. When these expectations are not met, staff will communicate with parents. Repeated attempts to resolve disruptive behavior can result in suspension or expulsion.

PHA holds a zero-tolerance policy for bullying and fighting. Bullying includes any actions or language that seeks harm, intimidation, or coercion. Any acts of bullying will be addressed immediately and communicated with parents of involved students.

Digital Use

Cell phones will remain silent during the school day. Phones will remain in student's assigned locker when not in use.

If a student needs to speak with a parent, they will be permitted to use a private space outside of the classroom or use the classroom phone. Otherwise, cell phones should not be used during academic or athletic times.

Students will have access to their phones during lunch.

Cell phones are not permitted in any locker rooms.

Use of gaming systems or video games on the computer are not permitted at PHA.

Students will remain on academic websites during academic time.

Dress Code

All articles of clothing will be school-appropriate. Students must always have a t-shirt on.

Pajamas are not permitted.

Students are expected to have athletic shoes for workouts every day. Slides, sandals, or slippers are not permitted in the gym or during workouts.

Food

Lunch will be offered Monday-Thursday. All students will bring their own lunch on Fridays. Students can opt in to the meal plan (Monday - Thursday) or bring their own lunches.

The lunch plan is \$150 per month. A link to enroll in the lunch plan for the school year will be provided in August.

DoorDash, Uber Eats, and other food deliveries are only permitted during lunchtime.

Dietary restrictions should be communicated to staff on the enrollment form. Staff will communicate with the caterers.

When preparing snacks for school please try to support healthy nutrition. Refrigerators are available for student use. Students may also pack lunch and snacks that can stay in their locker.

Inclement Weather Policies

Decisions about school closures will be communicated in an email to all parents as soon as possible.

PHA will monitor guidance from neighboring school districts and the City of St. Peters. The administrative team will also consider the geographic regions from which students and staff travel to assist in making the safest decision.

Parents always have the choice to allow their students to work remotely. Training that is canceled due to inclement weather will be rescheduled.

Internet Policy

Student computers will be connected to the PHA wireless internet. To ensure appropriate bandwidth, the PHA Wi-Fi will not be shared with students for use on other devices.

Aristotle classroom management software is required. This software will only be used by staff while students are present at PHA.

Medical Protocol

If an injury or illness outside of PHA results in a player being seen by a physician, please send a note to the PHA Athletic Trainer. Concussion protocol and return-to-play protocol will be supervised by Dr. Bill.

PHA staff can issue medication to students with a doctor's note or parent consent. All medications will be kept in a secure location.
