 - b. Any rink updates: Already discussed.
 - c. Jersey sample dates: June 19 5:45 to 7 p.m. All jersey sizes and sock sizes will be available for players to try on. We signed an exclusivity agreement with Pure Hockey. Meaning they will give a sponsorship check. \$20 per player, \$150 for coaches, discounts for purchases. Designated sales rep and customer service. 12U can't wear last year's jerseys because we have a contract specifically for West Virginia Wild. Amanda: I think it would be fine if 12U wants to use old jerseys, but if there's a third jersey need to go through Pure Hockey. Jenna: Could create a problem if other teams don't purchase the new jerseys. Go to head coaches on designs.
