Meeting with JLG- budget

Should have estimates in 2-3 weeks.

Notes from meeting as follows:

Ballard King: Operational budget was reviewed, and a few changes need to be made (ice rental, change in HS payment, city subsidy decreased). Once facility update is done to include 3 options.

- 1. Year round covered 2 sheet facility.
- 2. One sheet and a second outdoor covered sheet that can convert to turf in the off season.
- 3. One sheet a second space that is turf to start with an eventual permanent second sheet.

- JLG: Facility drawings updated with minor changes to the two sheet drawings. It is still the same total space. Next steps:
- 1. JLG is to complete estimates by the end of June for:
- a. Year round covered 2 sheet facility.
- b. One sheet and a second outdoor covered sheet that can convert to turf in the off season. It was discussed that using our mat system likely represents a savings of approx. 1.2M 1.4M
- i. i. The biggest variable here is how we affect the life of our mat system by taking it in and out in the off season
- c. One sheet a second space that is turf to start with an eventual permanent second sheet
- 2. Once the estimates are done, drawings will be updated to include all 3 options. We discussed we need drawings of all 3 options to engage in fundraising and sponsorship discussions.

Hoping next meeting is within the next 2-3 weeks for "final" operational budget and renderings and cost estimate for the build.

After we get the above from JLG and Ballard King we will do feasibility study to find out how much we can raise to determine which option we can run with most successfully asap.
