- A. <u>Approve Budget</u>- ice expenses have increased over the last couple of years. Planning a 7.5% skater increase.

VII. Reports By Appointed Board Members (20 min)

A. Apparel Directors

- 1. Meeting with Trending Now on Monday to review apparel website. We shared the feedback expressed at last month's meeting with them (black on black clothing options, different hat designs). We will likely open the store some time in August as we've done in previous years.
- 2. Anniversary Patch: Design shared with Trending Now and we asked for the cost to print out and that the design be included on some apparel items. We should know more on the cost for the prints after our meeting. (Idea to get heat presses from members and put patches on jerseys at the Classic was suggested at Officer's Meeting)
- 3. Socks: Last season two sock designs were available for families to purchase. We released the new design but TN had a lot of inventory with the old design and wanted to decrease it.

Currently, TN has the following counts leftover with the old sock design: OLD DESIGN: 13 - 22° White, 3 - 24° White, 17 - 26° White, 9 - 26° Black

Question for the board:

Do we want to buy these and sell them as practice socks at the Classic, or just sell the new sock design on the website? What is the cost to buy these out? Checking.

4. Jerseys: Working with both vendors this season. The initial order needs to be placed by 9/1 to ensure that the jerseys arrive in time for the classic. Jersey costs will be the same as last season, but an increase

in the shipping fee and Black Biscuit jersey cost for ad-hoc orders is needed to cover tariff and shipping fee increases per vendor recommendation.

Proposed Jersey costs shared with the president and treasurer for approval. We will use Crossbar again for Jersey ordering and number selection during registration.
