Treasures Report: Tina Lang- Balance \$84,044.42. \$10,000 less than last year but we did a \$25,000 for Kennedy Park. Some of this years travel payments were in last years budget so it should be the same this year. Gym rentals increased so those need to be tracked separately. Concessions Season Recap Went well this year. Volunteers spots still hard to fill at times. During the season \$24,000 in sales with about 50% profit.

2026 Travel Costs- 2025 Green was \$500 and Silver was \$300. Turner Cost will be going up \$5. Cost will remain the same for next year. If no new jersey needed, then \$50 credit will be done.

Concessions and Volunteer Proposal 2026: Hours will be tracked in Crossbar. Hours will be different for rec and travel.
