An oral VOTE was cast to accept the treasurer's report: all present voted Yay, zero nays or abstentions

Program Director Report

- The requirement to have a minimum of 2 house teams for each age group was not found in the handbook.
- Ice will not be available at the HoCo until 9/22 and at the Dee around the middle of October
- Practicing on Saturdays and Sundays consistently this season may need to happen to fill ice time blocks

- The draft for house teams should occur no later than 10/13–Division coordinators dictate needs for evaluation
- Old Timers Tournament tentatively scheduled for March 12-15, 2026, so hockey Saturday may possibly be on March 7, 2026
- The association desires to schedule a checking/competitive contact clinic for CCJHA players
 - Older coaches will be asked to help out in running this
 - Need to find a date that works
- An Earn Your Stripes North Event will be on September 20th at the HoCo
 - There will be games throughout the day and any registered 10U skaters can play
 - All referees, new and old, are encouraged to come as there will be instruction for all
 - There should be money from the grant that we received to pay for the clinic, making it free for participants
 - They will need their USA Hockey number to participate
 - Volunteers are needed to keep the score and clock
- As of right now, nobody has approached the board about wanting to coach a midget team
- No travel teams want to join the NIHL per the coaches' decisions
- The topic of CUP league participation in ages other than 14U was discussed. It gives the house teams a few more options to play different teams.

A motion was made to approve 12UB teams (14UB has already been in the CUP League from past years) to join the CUP League for the 2025-2026 season by Ryan Bennett; seconded by Ryan Galerneau. The motion passed.

An oral VOTE was cast to approve 12UB teams joining the CUP League: all present voted YAY, zero nays, zero abstentions.

Coaching Director Report

- There is a spreadsheet of current coaches registered and what is still required for some. (See attachment 2 below).
- There is a request to move up a 6U player to 8U. The request was made by both past and present division coordinators.

A motion to approve the move up of Gavin Rouleau to 8U was made by Jenn Capello; seconded by Rudy Gemignani. The motion passed.

An oral VOTE was cast to approve the move up to 8U for Gavin Rouleau: all present voted YAY, zero nays, zero abstentions.

• Rudy Gemignani has offered to do all modules to help with goalie coaching at all age levels

Pending the proper certification, a motion was made to approve all coaches listed (see attachment below), plus the addition of Scott Blake, Mike Beutler and Lee Mayra by Jeff Peltier; seconded by Mark Hendrickson. The motion passed.

An oral VOTE was made to approve all coaches listed (with the addition of Scott Blake, Mike Beutler and Lee Mayra) for the 2025-2026 season: all present voted YAY, zero nays, zero abstentions.

Equipment Manager Report

- There was a good turnout for the goalie training
- It has been discovered that the 8U goalie equipment has not been aired out properly and mold was found in multiple sets
 - o 3-5 more sets of chest protectors and pads are needed
 - Rudy will work on getting quotes together for what is needed and present at next month's meeting

Officials Report

• Jason has been working with Amy on the Earn Your Stripes Clinic

Registrar/Safe Sport Report

- The incentives for early registration seemed to work good
- There are still a handful of travel players that need to register before practice begins
- The 12UA team currently has 11 skaters registered. This meets the minimum number of players needed to house a team, per the CCJHA Handbook
- Every team needs a Head Coach, Assistant Coach, Team Manager and Locker Room monitors listed and credentialed

Booster Club Report

- An awards night is planned for September 24th at 6pm at the Houghton High School. This will also be used as a kickoff for the new season and a chance for information to be relayed to parents for the year
 - Reminders need to be sent out to last year's coaches

Finance Committee Report

- There was discussion about special circumstances and registration costs. Due to injuries, etc.
 - Per the CCJHA Handbook, "Injury or illness that results in the player being unable to play for the remainder of the season. Refunds will be pro-rated based on ice time utilized."

Due to time, a discussion about local players being rostered and playing outside of the area (in particular, girls who don't have a local team to join in their age division), but wanting to get on the ice with the CCJHA was tabled until next month's meeting when registration numbers will be more set as well.

A request for a goalie to be added to the 19U girls team, in case of emergency, was also tabled to next month.

• Work is being done on the Copper Shores Community Health Foundation grant for on and off-ice equipment

- CCJHA Scholarships: 3 applications as of 9/10; the deadline is 10/1/25 so spread the word
 - o A committee is needed to review and award the money to recipients after 10/1
 - o Mark Hendrickson will help head this committee
- Travel jerseys have been ordered and 6U mock-ups are being built
- The number of 8U teams will be based on registration numbers
 - Hancock Fire will remain a sponsor
- MTU needs helpers to usher over Thanksgiving Break; whichever team(s) volunteer to do will get paid
- Helmet logos-Calvin will work on getting some fonts to look at to help build the new brand

Tournament Director Report

- No teams have registered for the November Gale tournament that we had hoped to host the weekend of October 31–November 2nd
- Brainstorming on how or what to do in place of this fundraiser
 - Possibly a golf tournament in early spring/summer?
