- To decrease to even 10 hours per family for volunteering we need to determine where we can go without volunteers for 2 hours x 374 families registered last season= that's 748 hours.
- Tryout security was 81 hours. Tryout bench door opener (all levels) was 46 hours.
- Cutting down to 1 penalty box for Twaddle and McLaughlin is a total of 130 hours saved.
- The new Squirt tournament (with only 1 PB per game) adds an additional 76 hours above what we used for ELKStravaganza.
- We could save some hours by doubling up Board Movers with other positions at the Mite tournaments. My worry is people will not read the description properly and will not do the Board Mover responsibility. For the Barn Burner this would save only 12 hours.
- I do not have a game schedule for Jamboree to do the math- It is a bigger tournament so it would save more hours but probably not enough to make much difference.

- We have 5 tournaments- how does this compare to the other Associations we are comparing our volunteer hours to?
- We also ran short at the SKATE Banquet and had trouble filling the Mite Jamboree: this was with a 12 hour requirement.
