

2023-Alumni Hockey Game Rules and Waiver Agreement

All players must read and sign this agreement before they step on the ice.

1. There will be no fighting. Keep it clean! Anyone who gets out of line will be asked to leave.
2. There will be no body checking.
3. There will be no slap shots.
4. No-bringing cans or bottles of beer on to the bench area.
5. Participants need to pick up after themselves when leaving the lock room.
6. Do not bring valuables into the locker rooms.

Alumni Hockey Waiver of Liability, Release Assumption of Risk & Indemnity Agreement .

For and in consideration of the participant's participation in the Alumni Hockey game run by the [Blue Line](#) Club of Beloit or its Board of Directors, relinquish any and all liability for and cause of action for personal injury, property damage or wrongful death occurring to participant arising out of participation in the [Blue Line](#) Club of Beloit or its Board of Directors Alumni Hockey game and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant may have are hereby relinquished and the participant (or parent(s)/legal guardian(s)) does(do) so on behalf of my/our and participants heirs, executors, administrators and assigns.

Participants acknowledge, understand and assume all risks inherent in ice hockey and any team activities, and understands said sport and activities involve risk to participant's person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise there from and I/we have full knowledge of said risks. These risks and dangers may be caused by negligence of the participant or the negligence of others, including the "releasees" identified below. It is further acknowledged there may be risks and dangers not known to us or are not reasonably foreseeable at this time.

Participants acknowledge, understand and assume all risks, if any, arising from the conditions and use of the ice hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks, for negligent selection of certain releasees, or negligent supervision or instruction by releasees.

Participants agree if any claim for participant's personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and save harmless releasees from any and all claims or causes of action by whomever of wherever made or presented for participant's personal injuries, property damage or wrongful death.

It is the purpose of this agreement to exempt, waive and relieve releasees from liability for personal injury, property damage or wrongful death caused by negligence, if any, of releasees. "Releasees" include The [Blue Line](#) Club of Beloit and its Board of Directors, other participants and supervisors, and the CITY of BELOIT. Participants acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of releases, that they are fully advised of the potential dangers of ice hockey and understand these waivers and releases are necessary to allow amateur ice hockey to exist in its present form.

The Blue Line Club and/or City of Beloit are not responsible for security of personal items or valuables in the locker room(s).
