## **CAHA Financial Policy**

**PLAYER FEES** - Player fees are set by the Board at the beginning of each season, and are calculated based on practice and game ice budgeted with teams of 12 players. Every effort will be made to provide a consistent experience each season.

**PAYMENT SCHEDULE** - Payment in full made be made at the time of registration. If a payment plan is desired, a deposit of approximately 25% of the total season fee will be required at registration, with the remaining balance dividing into three equal payments due as listed on the registration platform.

**REGISTRATION FEE** - Total season fees include a \$100 non-refundable registration fee. With registration, each player will receive ten tickets for the yearly association raffle. The player may choose to sell those tickets to recover \$100 or may keep the tickets for themselves.

FINANCIAL ASSISTANCE - Should any child have the desire to play hockey without the financial means to participate, the parent or guardian should contact the Board Treasurer to make arrangements. Players seeking financial assistance are required to apply for the MAHA scholarship prior to applying for CAHA scholarship funding. The \$100 registration fee is not eligible for financial assistance, and may be recovered by selling raffle tickets. For additional information, refer to CAHA's financial assistance and scholarship program, and reach out the the CAHA treasurer.

**PAST DUE BALANCES** - Player fees must be current to participate in team events. The Treasurer or the Treasurer's designate will keep an individual accounting of each player's fees. Upon notification of delinquency from the treasurer, the player will have 7 calendar days to bring their account current (or) enter into a satisfactory payment plan with the treasurer. Failure to pay past-due balances or enter into a satisfactory payment plan may result in suspension from all team activities until the delinquency is resolved.

**REFUND REQUESTS** - CAHA recognizes that extraordinary circumstances may require a registered player to withdraw. Under these circumstances, the Association will refund fees paid by the withdrawing player according to the following schedule (USA Hockey player registration fee is nonrefundable):

The required \$100 registration and raffle fee due as part of your registration is non refundable.

Players requesting release after registration, regardless of the reason, must submit the request in writing to the CAHA treasurer and CAHA registrar. This proration will occur based on date the

request is received by the treasurer and registrar. The player will owe the following participation fees before being released:

After registration, but before participation in practices or games - \$300 (Maximum)

Request submitted through September 15th - 25% of yearly fee

Request submitted through October 15th - 50% of yearly fee

Request submitted through November 15th - 75% of yearly fee

Request submitted through December 15th - 100% of yearly fee.

In addition to any prorated yearly fees due, the player will also be responsible for the cost of any equipment or apparel provided by CAHA, if applicable.

Jerseys are purchased by each player, and are the sole responsibility of the player. CAHA will not reimburse the cost of any jersey purchases under any circumstances.
