Discussion around the plan to add two new board positions (Tournament Director and Growth and Development Coordinator). Due to challenges filling current board positions, the board tabled the discussion to add the new roles to next month's discussion.

3. Fall/Spring Skills (SB) -

Subcommittee meeting was held with Steve B, Todd F, Derek C, Jack K -

Goal: High-tempo, fun, engaging skills sessions that are affordable and sustainable for the growth and development. CAHA would like to offer skills clinics in the months of April and September 2025.

- Target Cost: Keep the price point low (\$40 or less - \$10/session).
- The committee would like to bring in some new coaches/trainers to give some variety.
- Limit: There would be a max of 30-35 kids per session.
- Strong desire to include coaches into the learning process to carry into the season so it can be replicated throughout the year.
- Spring Proposal:
 - Offer two 2-hour sessions with Mitch Parsons (April 3 & 10)
 - Offer two 1-hour sessions with alternate or CAHA coaches (April 17 & 22)
 - Motion to approve this format- Heather D, 2nd AT, All in Favor
- Estimated cost: \$1,200 per season
- Annual budget allocation: \$2,400 (Spring + Fall)
