Savings:

- Association is the healthiest it has been in many years.
- We currently have approximately one half of a season in cash reserves. Our goal is one full season. We grew our reserve balance approximately \$15,000 from last year, primarily due to successful fundraising. The growth however was down from the prior year, largely due to lower sponsorship contributions.
- 24/25 benefitted from mandatory association raffle as well as large teams at squirt, peewee and JV level. Bantam teams as well as cross-ice were budget neutral.
- Cross Ice numbers continued to be strong. LTP saw the largest number as far back as our records go.
- Major equipment investment this season was the rigid shooter tutor boards (\$1350) We invested nearly \$900 in helmets for our youngest players.
- We paid for broken glass due to carelessness on ice. Room for improvement
- Net income for hosting (all tournaments) was about 5k. This includes Fall Freeze (x2), District, Adrays, and HNIC (x2). If we want to continue we will need to find a tournament director.
- Sprint (and Fall) development skates were well attended. Some player development funding used to subsidize.
