OUR VISION

Our organization strives to create a positive and inclusive environment where veterans can heal, connect, and grow through hockey. We aim to reduce or remove financial barriers to participation and leverage our growing community to make a meaningful impact at the local level. In the immediate future, we plan to fund and operate two adult recreational hockey teams in the Chiller Adult Hockey League, welcoming both beginners and experienced players.

Additionally, we will host monthly Stick & Puck and Drop-In Hockey Sessions to help players develop their skills while receiving mentorship from seasoned players and building team camaraderie. Looking ahead, we intend to partner with reputable training companies for specialized skills clinics, collaborate with other Warrior Hockey organizations for events, and compete in national Warrior Hockey tournaments such as the USA Hockey Warrior Classic.

Our mission prioritizes being a community-first organization, with national-level participation as a secondary focus. The Chiller Adult Hockey League, Stick & Puck sessions, Drop-In Hockey sessions, and skills clinics will be open to all honorably discharged veterans, Active-Duty and Reservist servicemembers, and Gold Star family members. National events such as the USA Hockey Warrior Classic, exhibition games, and networking opportunities will be reserved for disabled veterans who meet the eligibility requirements, per USA Hockey's Warrior Hockey guidelines.

DISABLED HOCKEY

The disabled hockey pillar focuses on disabled veterans and activities pertaining to USA Hockey's Warrior Hockey which is a discipline of disabled hockey. This includes participation in USA Hockey sanctioned events such as the Warrior Classic and Warrior Nationals. In addition to this, the Warrior Hockey team will participate in and host events with other Warrior organizations such as tournaments and exhibition games.

VETERANS HOCKEY

The veterans hockey pillar focuses on improving the lives of veterans, service members, and gold star families in the greater Columbus area. CWH leverages the existing adult recreational hockey program hosted by The OhioHealth Chiller rinks to create opportunities to establish meaningful peer-based support networks, develop a healthier lifestyle through physical activity, and heal from trauma through the sport of hockey.

DONATION ALLOCATION

- Chiller Adult Hockey League Team Dues for All 3 Sessions (\$10,350 per team per year)
- Once monthly Stick & Puck and Drop-In Hockey sessions (\$680 per month)
- Veterans Hockey Home and Away Jersey, Pant Shell, and Socks (\$135 per player).
- Operating costs for website, email, fundraising and branding materials
- Disabled team uniforms, adaptive equipment, event fees, and other related expenses
- Gear and lessons for Veterans new to hockey (Planned for future / Reliant on funding)
- Mental Health Clinics / Team Building Activities (Planned for future / Reliant on funding)



SPONSOR PACKAGES

Sponsorship packages are for the duration of I year and will be from January I – December 31. For our inaugural 2025-2026 season, early donors will receive 3 additional months of advertisement and partnership with the first year's sponsorship period running from September 2025 to December 2026. Annual sponsorship coordination will begin at the start of the fiscal year on October 1st with updated sponsorship package costs and subsequent advertisement offerings being made available to potential partners. Existing sponsors will be given priority for renewal.
