 - Feb 21-22, 2026 12U-18U AA, 16U UA & LA, 18U UA & LA
 - Feb 28 March 1 2026 UA, LA & Wales

- Was opened to floor for concerns/questions about meeting discussions or things from meeting None heard.
- Rule change suggestion from Tri-City to change handshaking to before game instead of after
 - Some think post game handshake is part of learning good sportsmanship, responsibility, etc. Others think, especially for older ages, it will prevent post game incidents if game doesn't go well.
 - Clubs divided will vote next month.
- Also suggestion from Tri-City adding ice cut between 2nd and 3rd periods for 16U and 18U AA
 - Could add 10min to ice slot time
 - Suggestion of you can't add additional cuts and shorten period, but cut can be forfeited if it doesn't fit into time slot
 - Pros and cons discussed
 - Would need to know how much more SHOA would charge
 - \circ $\;$ Tri-City is going to pilot this for this upcoming season
- Roanoke is back again to ask to join CBHL
 - Did a voice vote calling for anyone to vote in favor of them joining
