COMMISSIONER UPDATE / Tom Crosson

- Rules Changes USA Hockey approved Ruled changes for 2025-2029
 - Allowing delayed/tag-ups off sides
 - o and allowing icing while on pk/short handed
 - o Applies to youth 16U, 18U and Gilrs 16U and above
- Penalty Length Changes have been adjusted to align with period lengths
 - o Period length of 12-16:59min with have 90sec penalty
 - With 4min major, 8min mis conduct
 - except for 16AA and 18AA and NTB Girls
 - o Period lengths of 17-20min the standard 2min minor penalties apply
 - PVAHA will follow USA hockey rules for penalty lengths
- AHF (Black Bears) has changed their scoring/game management system
 - This will NOT affect CBHL, us as CBHL will stay with GameSheet
- Reminder on Playoff Dates 2026
 - Jan 31 Feb 1st All girls divisions at PWIC

- Rule 12.0 Playoffs Period Lengths Girls
 - No change
- Rule 8.0 Game Information regarding Game periods Girls

NEW BUSINESS

- Was opened to floor for concerns/questions about meeting discussions or things from meeting – None heard.
- Discussion on team classifications, particularly at the AA level with growth at the 16AA level
 - o 16U AA has reached 21 teams (which is approx. 50% of the 16U pool)
 - Teams declaring themselves as AA without appropriate skill level
 - Propose two possible solutions:
 - Movement rule to limit player transfers between clubs
 - Play In Tournament system basically a tryout, something that would restrict the top division to a fixed number of teams
 - Club conversation was with concern for clubs leaving cbhl to go independent while others stating that parents and clubs are chasing higher classifications.
 - o Also the naming of division could create a stigma
 - Discussions to continue
- Reminder for all player of age 18 to complete background checks and get safe sport completed
 - USA hockey is updating system to show all certifications on a single dashboard page
