1. No swearing or abusive language on the bench, in the rink, or at any team function.
2. No lashing out at any official no matter what the call is. The coaching staff will handle all matters pertaining to officiating.
3. Anyone who receives a penalty will skate directly to the penalty box.
4. Fighting will not be tolerated. Fighting will result in an appearance before a Discipline Committee.
5. There will be no drinking, smoking, chewing tobacco, or use of illegal substance at any team function.
6. I will conduct myself in a befitting manner at all facilities (ice rink, hotel, restaurant, etc) during all team functions.
7. Any player or team official who cannot abide by these rules or violates them will be subject to further disciplinary action.

CUYHA

In an effort to make ice hockey a more desirable and rewarding experience for all participants, the CUYHA Executive Board has instructed the Officiating Program to adhere to certain points of emphasis relating to sportsmanship. This campaign is designed to require all players, coaches, officials, team officials and administrators, and parents/spectators to maintain a sportsmanlike and educational atmosphere before, during, and after all CUYHA sanctioned games. Thus, the following points of emphasis must be implemented by all On-Ice Referees and Linesmen:

Players

1. A minor penalty for unsportsmanlike conduct shall be assessed whenever a player:
 - a. Openly disputes or argues any decision by an official.
 - b. Uses obscene or vulgar language at any time, including swearing, even if it is not directed at a particular person.
 - c. Visually demonstrates any sign of dissatisfaction with an official's decision. Any time that a player persists in any of these actions, they shall be assessed a misconduct penalty. A game misconduct shall result if the player continues such action.

Coaches

1. A minor penalty for unsportsmanlike conduct shall be assessed whenever a coach:
 - a. Openly disputes or argues any decision by an official.
 - b. Uses obscene or vulgar language in a boisterous manner to anyone at any time.
 - c. Visually displays any sign of dissatisfaction with an official's decision including standing on the boards or standing in the bench doorway with the intent of inciting the officials, players, or spectators. Any time that a coach persists in any of these actions, they shall be assessed a game misconduct penalty.

Officials

1. Officials are required to conduct themselves in a businesslike, sportsmanlike, impartial, and constructive manner at all times.
2. The actions of an official must be above reproach. Actions such as "baiting" or inciting players or coaches are strictly prohibited.

3. On-ice officials are ambassadors of the games and must always conduct themselves with this responsibility in mind.

Parents/Spectators

1. The game will be stopped by on-ice officials when the parents/spectators displaying inappropriate and disruptive behavior interfere with other spectators or the game.
2. The on-ice officials will identify violators to the coaches for the purpose of removing parents/spectators from the spectators viewing and game area.
3. Once removed, play will resume. Lost time will not be replaced and violators may be subject to further disciplinary action by the local governing body.
4. This inappropriate and disruptive behavior shall include:
 - Use of obscene or vulgar language in a boisterous manner to anyone at any time.
 - Taunting of players, coaches, officials, or other spectators by means of baiting, ridiculing, threat of physical violence, or physical violence.
 - Throwing of any object in the spectators viewing area, player's bench, penalty box, or on ice surface, directed in any manner as to create a safety hazard.
