 - The A/P on the Balance Sheet shows \$6,850.00. This consists of \$6,700 in Kwik Trip cards that still need to be purchased. I calculated this amount based on the registration numbers. If this number changes once Niki actually buys the cards, I will adjust that. I wanted to put this in to get a good idea of what we will actually make off the fundraiser, which will be \$10,520.00. The other \$150 is checks that have been written for reimbursements on coaching clinics that have not been cashed.
 - On the P&L Statement (Statement of Activity), it shows a negative number in the HHS Program column. We need to disregard this, and add that number back into the total. This amount has been transferred over from the Savings account to the Checking account, but for record keeping, it shows as a negative.
