Squirt Division Team Formation

A detailed discussion was held regarding team formation for the Squirt division, with input from multiple parents and coaches.

- Multiple Parents and coaches spoke up and wanted to only do a B level schedule for the 25-26 season based off of numbers and development opportunities for the kids.
- Based on prior season numbers, 16 skaters are projected for the 2025–26 season.
- The recommended roster for a single Squirt team is 10 skaters and 1 goalie. Two teams would ideally require 20 skaters and 2 goalies.
- Motion: Jared Baldwin moved to form two Squirt teams (B1 and B2), contingent upon meeting the necessary player count. If the numbers are not met, the Board will form a single B-level team.
- Motion seconded by Brent Olson. Motion carried.
