Parent Code of Conduct – Elevated Standards

I understand that violations of any of the commitments outlined below may result in disciplinary action, including being restricted from attending practices or tournaments. In serious or repeated cases, my child may be removed from the program entirely, and I will remain responsible for all financial commitments as agreed upon at the time of registration.

1. Sideline Behavior & Sportsmanship

- I shall remain within designated spectator areas exclusively throughout all games.
- I shall exemplify sportsmanship by treating coaches, officials, tournament organizers, and players from both teams with unwavering courtesy and respect.
- I shall offer hearty applause for acts of commendable sportsmanship and equitable play witnessed during matches.
- I shall retain composure over my emotions, setting an example of self-discipline.
- I shall voice my encouragement for my child's team, fueling their collective spirit.
- I shall champion the collaborative essence of the sport.
- I shall comprehend that any form of physical or verbal intimidation is strictly forbidden and constitutes unacceptable behavior.
- I shall robustly endorse efforts to eradicate verbal and physical abuse from organized volleyball endeavors, encompassing language usage.
- I shall acknowledge that behaviors deemed inappropriate by comparison to accepted norms are unequivocally unacceptable.

2. Parent-Coach-Official Boundaries

- I shall refrain from offering unsolicited coaching advice to the coach, including directives on player selection or substitution.
- I shall abstain from attempting to coach my child during the course of the game.
- I shall uphold the dignity of the officials, refraining from attempting to influence their decisions during the match.
- I shall channel any concerns or issues to a designated representative of the AZ Region, refraining from self-initiated interventions.

3. Role Modeling & Personal Conduct

- I shall exclusively participate in all volleyball-related events in a sober and drug-free state.
- I shall cultivate a culture of relentless effort and ethical striving, thereby contributing to enhanced performance and active involvement.
- I shall motivate my child to engage in volleyball not solely for competition but also for the pure joy of participation.
- I shall internalize the reality that my child's volleyball journey is a personal growth experience rather than a reflection of my aspirations.
- I shall immerse myself in comprehending the game's rules, fostering a heightened understanding of on-court proceedings.

4. Athlete Safety & Responsibility

- I shall actively endorse the engagement of athletes in volleyball free from any involvement with drugs, tobacco, and alcohol.
- I shall exercise complete responsibility for my child's presence and behavior at all practices and games, recognizing that RUSH Volleyball Club LLC assumes no responsibility for unsupervised players.
