 - a. Outdoor Arena: Skytta has been contacted regarding sponsorship of our outdoor rinks.
 - b. Arena Update Kenny Kolquist: summer ice is nearly completely booked. We have 668 players signed up for Summer League. There will be a separate girls' league for the first time. Camps are full. The arena is going to run a camp to fill up camp slots and get some alum to come and help. P/L is on track. Staffing is good, we have staff who want more hours which will be good when the new rink opens. December 19 is the projected completion date. Arena budget looks good at this time. Locker rooms continue to present a problem as we lost 3 to construction. They are working

on temporary locker room facilities. Trailers may be used for temporary locker rooms for fall and for soccer.
