

Edge Volleyball Virginia 2025 Season Participation Agreement

Section 1: Conditions of Participation

We, the parents/guardians of _____, (“Athlete”), whose date of birth is _____, hereinafter collectively designated as “Members,” read and understand the supplied information concerning the policies and practices of Edge Volleyball LLC., hereinafter designated as the “Club.” We agree to join the Club for the 2025 Junior Volleyball Season (“2025 Season”). The 2025 Season shall be defined as the period beginning on August 1, 2024, and concluding on the 15th of July 2025, and measured for the purpose of training and competing in events governed and sanctioned by USA Volleyball (“USAV”), the Amateur Athletic Union (“AAU”), and the Junior Volleyball Association (“JVA”). Members understand that Members are responsible for all fees due by the player, transportation to and from practices beginning Nov 4, 2025, as well as the transportation, hotel, food, and additional expenses not covered in this agreement, related to up to 5 single day tournaments and 5 two-day events.

Members understand the time commitment involved in practice. Membership in the Club is limited, and the Club may have denied others a position due to Members acceptance of a position in the Club. **Members understand that Members must pay the fee in full regardless of the duration of participation. If the Athlete is under the age of eighteen (18) upon execution of this Contract, they will be required, upon attaining the age of eighteen (18) years, to become an additional obligor for the performance of all obligations to the Club pursuant to this Contract as a condition to their continued right to participate. Should the Athlete fail to undertake this obligation in writing when requested by the Club, the Members shall nevertheless remain obligated hereunder.**

Section 2: Membership Fees Members agree to accept membership in the Club for the 2025 Season. Membership entitles the Athlete to participate in practices and 2025 Season sanctioned tournaments if needed.

The total membership fee for each player is set in addendum 1. The Membership Fee includes Edge Volleyball Virginia team fees for the 2025 Season. The Membership Fee does not include the costs of the Member’s/Athlete’s individual membership to AAU/JVA, and USAV. The Membership fee does not include costs for uniforms, warm up suits, t-shirts, and bags. (“Gear”). All Gear must be purchased separately through the Club sources.

Members may pay the Membership Fee in full at any time prior to the designated dates. Member agrees to pay the Membership Fee according to the attached payment schedule: **In the event of default on the obligations hereunder, the Members agree that they shall have additional liability for collection expenses and reasonable attorney’s fees of twenty-five percent (25%) of the amount due. In the event of default on any of the installment payments, the Club shall have the option of calling the entire unpaid balance immediately due and payable. The association can request suspension in USAV or AAU participation in the Old Dominion Region until full contractual payment is satisfied. Members agree to make all payments on time. Late fee of \$25 for payment received after the due date. Members understand that the Athlete will immediately become, and remain, ineligible to participate until Members’ account is current according to the payment schedule or an arrangement made with the Club Director or Club Financial Director. Player and undersigned persons are responsible for full payment of fees in the event of resignation, injury or any other reason player is unable to continue with participation.** Payments may be made in the form of Check payable to Edge Volleyball Virginia and mailed to Edge Volleyball.

Section 3: Waiver, Release, and Indemnity

Members acknowledge and agree that the sport of volleyball and all events associated with the Club involve the risk of property damage, injury, and/or death. Members hereby release the Club, its staff and agents from all liability arising from participation in the Club and agree to indemnify, hold harmless, and promise not to sue the Club or any individuals, facilities/organizations affiliated with the Club for any actions or inactions short of willful misconduct. This release, waiver and indemnification is intended to be construed as broadly as permitted under applicable law. Members must maintain Members own health insurance policy.
