Position Overview

The State League Director & Commissioner serves as both the operational leader and the governing authority for the **state-level BMX Youth League**. This dual position ensures the league functions effectively at the local level while maintaining compliance with the mission, policies, and standards of the **National Interscholastic BMX League**.

The **State League Director** is responsible for the growth, administration, and partnership development of the league throughout the state. The **Commissioner** role provides impartial oversight of competition, conduct, and rules enforcement to safeguard fairness, integrity, and athlete welfare.

Key Responsibilities

State League Director Duties

- 🌟 **Program Growth:** Expand scholastic BMX participation across schools, districts, and regions of the state.
- 🌟 **Event Management:** Organize, schedule, and oversee state practices, league races, and championships.
- 🌟 **National Alignment:** Implement initiatives and standards provided by the National Interscholastic BMX League.
- 🌟 **Financial Oversight:** Prepare and manage the state league budget, including sponsorships, fundraising, and resource allocation.
- 🌟 **Volunteer & Coach Development:** Recruit, train, and supervise coaches, track officials, and volunteers at the state level.



- 🌟 **Youth Enrichment:** Ensure league programs emphasize safety, inclusivity, skill development, and positive character-building.
- 🌟 **Marketing & Outreach:** Lead promotional efforts to expand awareness in schools, families, and communities statewide.

State Commissioner Duties

- 🌟 **Rule Enforcement:** Apply BMX rules and national policies consistently within the state.
- 🌟 **Dispute Resolution:** Serve as the final authority for state-level protests, discipline, and conduct concerns.
- 🌟 **Integrity Oversight:** Ensure competitions are fair, impartial, and sportsmanlike.
- 🌟 **Code of Conduct:** Monitor compliance from athletes, coaches, and volunteers, issuing appropriate sanctions as necessary.
- 🌟 **Policy & Reporting:** Provide recommendations to the National League on policy improvements and submit compliance/growth reports.

- 🌟 Strong leadership and organizational experience in youth sports, education, or program management.
- 🌟 Knowledge of BMX racing, youth sports safety, and scholastic league operations.
- 🌟 Conflict resolution and impartial decision-making skills.
