Coaching Education Program: Marisa Berti - First Level 1 clinic was held last week. We are up to five coach developers in CT. There will be a level 2 and Level 3 in October.

Registrar: Kendra Tompkins - Every program and affiliate needs a Board Roster. If you are not registered as a volunteer please complete Safe Sport and Background Screening in order to be added to a Board Roster. Safe Sport expirations are causing many red-lines. Needed for 2008 birth years and older. A player can't be on the ice if they aren't on the roster. Please include jersey numbers on rosters and stickers. Credentialing will be on October 20th for Girls Tier 1 and Tier 2 - 14U, 16U and 19U at 6 PM. On October 23rd credentialing will occur for Youth programs - Tier 1 15O, 16U, and 18U and Tier 2 16U and 18U at 6 PM. A dual roster report will be run this week. Credentialing will be at West Haven. Players can only play for one CHC team.

District Commissioners: Heather Golisano - Lots of game misconducts coming in, system is labeling reports according to players team last year but that is being corrected. Every game misconduct is at least a one game suspension, fighting is two games. Please check that President email addresses are publicly viewable so District Commissioners can get in touch.

Eligibility Committee: A Squirt goalie was out and a Mite goalie was approved for two games. The committee is addressing goalie requests. Rosters freeze December 31st. If dual rostering girls they need to declare which team they will play for in States for Tier 1 and Tier 2.
