#### 5. 8U - Carly

- a. Teams were announced on 3/14/24.
- Discussion: need one head coach. We need to provide one head coach for each team for MN Softball administration and due to SAFA bylaws.
- Last jersey number was solidified on 3/14/24.
- d. Change for next year evaluation tryouts:
  - i. We will likely see younger and younger players. MN Softball has signaled that they are looking at 6U. There may be an opportunity for SAFA to start a younger program.
  - ii. We will likely need at least 18 parent evaluators.
  - iii. We would like to see more ongoing throwing and catching. In 2025, consider not having an infield tryout and instead focus on throwing and catching as a station.
  - iv. Evaluation check-in have number as the players check-in, ensure that the player has a number before parents leave evaluation.

#### 6. 10U - Terisa

- a. Finalizing coaches for all teams. Terisa will send out
- b. Changes for next year evaluation tryouts:
  - i. Next year arrive 1 hour earlier to set up 10U.
  - Next year do not allow multiple tryouts. If there is an optional additional tryout, do one after the full tryout.
  - iii. Consider end of February 2025 tryout to avoid spring breaks.
  - iv. Discuss setting up the stations differently: adjust outfield to be challenging while also being mindful of indoor gym set-up
  - v. Teams will be posted on Friday.
  - vi. Jen will send a list of tournaments to head coaches once coaches are assigned. Jeff will transition the head coaches in MN Softball.
