- Meeting Minutes from Meeting #1: Approved.
- Goalie Clinics (Howie)
 - Feedback was positive from all goalie families.
 - ProCrease: One of their coaches and one of ours for Squirts and two of their coaches with one of ours for the other age groups.
 - Three stations and they rotate through.
 - Squirt (4): Have a regular goalie coach.
 - Peewees/Bantams/Midgets (8 goalies, then 5 after Midgets end): No regular goalie coach for Bantams and Midgets. No high school coach can be on bench or ice during clinics with one of their high school player(s).
 - 1 clinic a month for the first three months (Sept, Oct, Nov) then two clinics per month when Midgets end.
 - Billing happens directly from ProCrease to EHA.
 - We will bill families directly for the package.
 - Actions:
 - Provide proposal to ProCrease (Adam) for what we are looking for and receive quote. (Howie)
 - Workout billing details including payment and ice costs. (Becky)

 - Ken has not received any responses.
