

## **2025 – 2026 Arvada Hockey Registration Agreement**

### **Registration:**

All player registration fees must be completed online. A non-refundable registration deposit is required to register for the Arvada Hockey Association (AHA). A player is not considered registered until the full registration deposit has been made. The remaining Season Player Registration fees for all teams and levels will be automatically billed upon team placement.

### **Refund Policy:**

AHA will issue a refund to a player ONLY if the player moves out of state prior to the start of tryouts/evaluations, if AHA is unable to field the minimum number of players for the team or if a player is officially rostered on a Tier I (AAA) team or a Varsity High School Team as of December 31<sup>st</sup> of the current season.

All other requests for refunds must be reviewed on a case-by-case basis by the AHA Board of Directors. Any refunds will be issued only after the roster freeze date, December 31<sup>st</sup>, of the current season. All approved refunds will be subject to a \$100 administration fee.

### **Financial Commitment:**

Once a player has been selected and rostered on a Travel, Girls, Rec or 8U team, they are responsible for paying the Travel/Girls/Rec/8U remaining season player registration fees. The remaining season player registration fees will be automatically billed upon team placement. Each player is also responsible for paying designated Team Fees to their assigned team – based on each team's individual budget.

All players are expected to participate in all tournaments selected by the Coach. Players not participating in a tournament are not entitled to any credit. This policy also applies to travel expenses associated with tournament/league games.

If a player is on an installment plan and chooses to leave the Association, that player is responsible for the remaining unpaid season registration fees and team fees assessed from the associated team. Arvada Hockey will not issue a financial release until all outstanding fees have been paid.

### **Volunteering Commitment:**

As a member of AHA, a player's family is expected to score or run clock for their family's share of their player's games. Members are also expected to volunteer during AHA tournaments that their player's team participates in. A minimum of 2 hours per family per player is required.

### **Player Placement:**

The Coaching Staff along with the AHA Hockey Directors have sole responsibility for player placement on a team. No refunds will be given for players who choose to leave because they did not make the team they wanted.

### **Code(s) of Conduct:**

All players will be responsible to review and adhere to the Arvada Hockey Player Code of Conduct. By signing this document, it is an acknowledgement of this policy.

All parents will be responsible to review and adhere to the Arvada Hockey Parent Code of Conduct. By signing this document, it is an acknowledgement of this policy.

**Privacy Information:**

I understand that receiving a directory and personal information of other families on my team is a privilege with responsibility. With that understanding, I agree that I will be respectful of others by waiting 24 hours before putting any complaint/concern in writing and then will email/mail my written concerns/complaints ONLY to the appropriate designated AHA individuals responsible for resolving issues. Please refer to the AHA website for the Grievance Policy and AHA Board member contact information. I further agree that I will not use the AHA family contact information made available to me to solicit business or other opportunities without prior approval from the AHA Board of Directors.

AHA reserves the right to disclose player information to other youth hockey associations with respect to the player's financial standing.

**Acknowledgement:**

I, the parent(s)/guardian(s) agree that I will abide by the rules of USA Hockey, its affiliated organizations, and sponsors. I acknowledge that I have read this entire online Registration Agreement and agree to abide by all procedures and policies set forth by AHA. In accordance with the procedures and policies of Colorado Amateur Hockey Association, this Registration Agreement may also be recognized as a Commitment Letter. I understand the refund policy as stated above and violation of any of the above policies may result in disciplinary action up to and including suspension or dismissal.
