**New business:**

- Parents of the 2011 AA defensemen claim Coach Bogard did not cross any lines
  - The parents of the unknown player confronted Coach Bogard approximately 10 minutes after the game
- 2011AA coaching group agreed to swap coaching roles around
- Parents are frustrated that they followed Coach Bogard from CAHA and they feel that Coach Bogard's ability to coach has been minimized.
- The sentiment was meant to support and back Coach Bogard, not diminish Coach Pinion's ability
- Jeremy- reiterated the family never formally or informally reported Coach Bogard
- Discussion of giving Coach Pinion time and then do a coach/parent/board meeting to help work through the issue
  - Brian wants to move away from coaches yelling at players
  - Brian will reach out to Coach Pinion in a few days, he'll clarify everything with coach Bogard
- The 2011 AA parents want Aaron to return
- Brian has offered for future issues to be brought to Brian, Jeremy, or Mark and not a nuclear email
