Taking those expenses into account, we have \$6,802.20 un-allocated. We need to determine how much of this we are willing to put towards lowering House dues. This does not include dasher renewals that have not yet been collected. Also, \$200 OYHA membership dues will be collected from each travel team in December. This covers \$800 of the \$1030 in expenses mentioned above. When we receive this money, it will put us at \$7,602.20 un-allocated.
