  - Ashley asks if the travel requirements are in the document, Erica says they are not.
  - Jody proposes the OYHA by-laws supersede the document at anytime.
  - Justin will post his highlighted version on Slack in documents.
  - Jason wants a date to get the document voted on so we can make sure everyone reads it and knows what it says. Justin says we need to take our time because it will not be in effect for this year anyway.

### **B.** New Business

- Discussion and vote on increasing Ref Pay Justin.
  - Erica has the proposal for the new ref pay in Slack. She proposes that once the ref has completed so many years with OYHA then we can give a bonus or recoup their fees for training at that time. Erica proposes to raise the rates for referees by \$10, Jody seconds, no opposed. The rates are in slack under "referees" from June 1st. Voted, motion passes, 8 yes, 0 no.
- Start of House League Ashley proposes October 23<sup>rd</sup> be the started date. Justin suggests avoiding weekends for practices or games, Kayla agrees. Justin suggests Monday through Friday.
  - SUGGESTION of schedule November 7th start date:

    - FRIDAYS: 8U-6U 5:45-6:45PM
    - Go through the first 4 weeks, then draft players for teams after those weeks of practices.
- Ashley suggests Peewee giving up a week of 2 practices to just 1 practice so that we can use the time for House league, Kaci said she will see if Bantam is able to do that.
- Start date of house league: 10/17, practice until 10/24. Draft 11/14. First game on 11/28.
- Snow-Days Kayla proposes that if school is cancelled due to weather then we cancel our
  activities as well. Regardless if it is county or city schools, we cancel if any cancel. Rest of the
  group agreed.
- Justin suggests a learn to skate or Hockey 101 so we can get more families involved or interested in participating. He is reaching out to McKenzie about gear and dates.
- Fall league House registration will run from End of August to right before Fall Break.
- Grievance: Erica brings up an incident from the last Summer League game where Greg Rush
  was heard bullying another player. He was warned by a referee (David) for his actions. She
  wants it documented and for Greg to be warned by a coach-in-chief. Jason said he will handle

warning Greg Rush. Erica is going to write out a grievance and once it has been filled out Jason will reach out to Greg.

- We have volunteered Matt to create a grievance form to use for cases like this. If anyone has a grievance within OYHA then this form will be allowed to be filled out and turned into the Vice President and the Secretary to be able to be posted within a a channel on Slack.
