 - b. Team Updates
 - i. 14U 20 players projected, still planning on two teams

- 1. Jake, Scotty and Emmett Baker (new) confirmed as coaches so far
 - a. Working to add at least one more to coaching staff
- ii. 10U 2 B teams, 3 teams total
 - Need to get through tryouts to confirm coach placements, but Matt Erholtz, Jeff Rodriguez, Ian Baker, and Adam Grimes to be involved as coaches.
- c. ATA Still working to figure out what that program will look like this season
 - i. Haven't gotten a firm answer, hoping to keep them on board
 - ii. Idea proposed to bring on another instructor to help and/or train for the future
- d. HS/CPHL Coaching
 - i. Luke DeWolfe, HS AD, hasn't named a coach and is out of town for the Summer.
 - 1. We know that at least one person has applied for the job officially
 - 2. Other candidates have been mentioned but it is unclear if anyone else has applied.
 - ii. Discussion on whether it makes sense to either name an interim coach or a coach for the fall to help with scheduling/planning
 - 1. We have oversight over the CPHL/Fall season
 - 2. Could affect the search/naming of the coach
 - Some coaches (Jake, Scotty, Emmett) have been asked to oversee HS Summer skills skates
 - 1. Would be helpful to the HS program to keep the ice slots for future/continued use
 - 2. Could run the program through SSYHA/Crossbar
- e. Away Tournaments
 - i. Vail is down a sheet of ice this year, and is doing a lottery for licants to their home tournaments
 - 1. This could affect the 10U and 12U teams.
 - 2. It is highly unlikely that both 10U B teams would get in
 - 3. Need to look into other tournament options for the early season
 - a. Aspen Fall Face Off is an option but not ideal
 - ii. Vail also no longer hosting Girls tournaments on MLK, will need to find another option for them as well
- f. SafeSport Coordinator
 - i. Holly Barclay committed for another year
- g. League News
 - i. CGHL/WCHL
 - Looking more likely that CGHL will dissolve and WCHL will create a Girls division with some crossover with the Front Range/RMHF Girls teams
 - 2. 19U Girls division will be slightly different with all of the Front Range teams joining the CPHL other than 1

VII. Operations Update – JBW

- a. Uniforms/Apparel
 - i. Uniform collection mostly complete
 - ii. Uniform ordering window will be open shortly
 - iii. Have also discussed an apparel package with Boathouse, our uniform supplier
 - 1. 4 piece package would be somewhere around \$100
 - a. Hoody, t-shirt, shorts, sweatpants. 24 order minimum.
 - 2. The wrinkle is that we need to purchase and distribute to get that price. Families could not order directly
 - 3. Discussion about jackets, would explore with a local supplier (BAP)
 - 4. We could be able to have as an add on at registration

b. Home Tournaments

- i. Waiting on CAHA to be able to launch tournament registrations
 - 1. CAHA in the process of switching to a new website which is delaying the process
 - 2. Last year we launched on July 1st, seems like this year we will see at least some delay in being able to launch
- c. Hockey Registration
 - i. Planning to launch in early August
 - 1. First need to finalize association docs and CAHA association application
 - ii. Discussion about double rostering between 14U and HS and related pricing
