There will be a charge of \$30 added to a player's account in the event that a check is drawn as insufficient. There will also be a charge of \$30 for every 15 days your tuition payment is late. These charges will be added and accrued each and every time the event occurs. If a player's fees are denied for whatever reason the player will be automatically suspended from all play 10 days from notification.
